# Appendix IV: Cross Roads Junior High Parent and Family Engagement Policy Statement of Purpose

Cross Roads Junior High is dedicated to providing quality education for every student in our district. To accomplish this objective, we will develop and maintain partnerships with parents and community members. Each student will benefit from supportive, active involvement of all members of the population. A positive link between home and school will create the most conducive learning condition for every child. These open communication lines will expand and enhance learning opportunities for all stakeholders.

**All** students will be expected to work toward mastering grade/subject level TEKS. Our campus recognizes the fact that some students will need extra assistance to achieve their full potential. The extra assistance is available to all students through the Title I program and various other educational services offered through the district.

Cross Roads Junior High intends to include parents in all aspects of the Title I program. Students will be given every opportunity for success through the development and enhancement of the home-school partnership.

# **Parent Involvement in Developing Policy**

Cross Roads Junior High's Campus Improvement Planning and Decision Making Committee (Campus Committee) is comprised of parents, community members, business representatives, the administrator, teachers, and other staff members. This committee will meet annually to discuss the design and implementation of the Parent and Family Engagement Policy.

Cross Roads Junior High will actively recruit volunteers for the Campus Committee through various avenues of publicity. Committee selections will produce a diverse group of stakeholders that represent an array of student populations served by the district. Meetings will be planned at convenient times and locations for all concerned parties.

# Parent Involvement Activities to Improve Student Academic Achievement and School Performance

One of the primary functions of the Campus Committee will be to identify ways that Cross Roads Junior High can provide assistance and support to its campus to create effective parent involvement. The administration will assist the campus in understanding the requirements of Title I, Part A and in planning for effective programs to help parents in improving academic achievement. Campus assistance may also include the distribution of informational handouts, which explain state academic standards, assessments, and curriculum.

# **Building the Schools' and Parents' Capacity for Strong Parent Involvement**

### **Annual Title I Parent Meeting**

## **Home-School Compact**

Members of the Campus Committee will be consulted in the design and implementation of the compact. All parents will be given a copy of the compact detailing the responsibilities that teachers, parents, and students have in helping students accomplish their goals. Students and parents are encouraged to discuss the contents of the compact.

#### **School-Parent Communication**

Parents will be informed of school activities through various avenues of communication throughout the school year. Newsletters, district website, district marquee, Blackboard notification system, Cross Roads ISD Facebook page, Remind App, Smore page, conferences, phone calls, personal contacts, teacher web pages, and written notices will be utilized to establish and maintain an open line of communication.

Parents are encouraged to contact the school and/or their child's teachers if they have any questions or concerns about the instructional program. Usually student or parent complaints or concerns can be addressed – simply by a phone call or a conference with the teacher.

# **Cross-Program Coordination of Parent Involvement Activities**
